**CASE CHECKLIST FOR DR. DAVID M. LECHUGA'S FORENSIC CASES**

**Items to be completed no later than 2 weeks prior to a scheduled examination:**

- Read and sign retainer agreement.
- Send retainer check or process payment (credit card) by calling Dr. Lechuga's office manager, Barbara. Barbara works Tuesday and Friday mornings (949-837-3358).
- Send all relevant documents via CD, flash drive, or a secure, web-based program, e.g., Drop Box, Hightail, We Transfer, etc. The documents should include:
  - Pre- and post-injury medical and mental health (psychological and psychiatric) records
  - Incident report(s)
  - Educational transcripts
  - Work records
  - Military records (if applicable, Department of Defense Form 214)
  - Depositions of involved parties
  - Other legal documents, if germane
- Remind examinees or their counsel about the scheduled start time for their appointment. There is a cancellation fee of \$2500.00 for no-shows, or non-emergent changes in the schedule appointment (see retainer).
- Provide examinees with my contact information, should they wish to confirm appointment or directions (office 949-837-3358).
